Sub : New Guidelines issued by the Ministry of DONER for projects under NLCPR


Sir

In inviting a reference to the letter No. and subject cited above I am directed to inform you that Joint Secretary, Ministry of DoNER in the letter addressed to the Chief Secretary, Assam has conveyed the recommendations made by the NLCPR Committee of the Ministry of DoNER in its 110th meeting. The Committee has recommended to adopt revised format for submission of Utilisaton Certificate & Quarterly Progress Report(copy enclosed). The Committee has also made the following two recommendations and it is requested for strict adherence of these recommendations as no request from State Government shall be entertained after lapse of the time lines mentioned:

1. After retention of projects under NLCPR scheme, State Govt. should ensure submission of DPRs at the earliest and not later than 8 months from issue of letter conveying retention of project failing of which project/s will be dropped/ deleted from retain list of projects without any further notice to State Govt. State Govt. shall not be entitled for any replacement /substitution for such project
2. After sanction of projects under NLCPR scheme, State Govt. should ensure issue of tenders and award of works for entire project within six months of issue of administrative and financial approval. Copy of work order issued by State Govt. should reach Ministry of DONER within next two months i.e. within 8 months from issue of administrative and financial approval failing which, project shall be dropped and funds released, if any, shall be adjusted against any other ongoing project. State Govt. shall not be entitled for any replacement /substitution for such project.

In view of the above, you are requested to follow the above mentioned guidelines and to submit UC & QPR in the revised format enclosed.
