**NOTIFICATION**

**No.FEB.331/2015/10:** In pursuance of Clause 3 of Article 166 of the Constitution of India and all powers enabling in this behalf and also *due to merger of Plan and Non Plan Heads*, the Governor of Assam is pleased to direct that the following further amendments shall be made in Schedule-I of the Delegation of Financial Power Rules, 1999 (as amended).


